MINUTES WELLS TOWN OFFICE
October 2nd 2018

1. Meeting was called to order by Chairman, Paul Woodruff Jr. at 7:00 PM.
2. Minutes of the September 18th meeting were read and approved.
3. Bills were studied and discussed and orders were signed.
4. Bill Humphries came to the meeting to discuss law enforcement, Board said the presence of more personnel might be useful. Mr. Humphries is a full time police officer and a Pawlet Constable. Ron made a motion to have Bill Humphries work with Gary Stomski as a special officer as circumstances require at an hourly rate. 2nd by Paul. Pass unanimously.
5. Dave Ricard said the grader is back. He has salt bids from Cargill for \$79.53 per ton and from the district for \$75.00 per ton. Ron made a motion to accept Cargill's price and purchase salt from them. 2nd by Paul. Passed unanimously. FEMA work is done.
6. Lisa Mattison and Joy Brewster spoke on behalf of the library. Beth Duquette declined to accept the assistant librarian position and so did Dennis Keimel. Joy named some other applicants who will be considered by the trustees at their next meeting. Ron questioned the need for an assistant when the library is only open 14 hours a week. Joy said the assistant would work 6 hours per week. Ron thought it would be better if Joy wanted the full 14 hours. Lisa said qualified subs should be sought. Ron suggested trying 6 months without an assistant.
7. Ron made a motion to appoint Carole Duquette and William Chmielewski as representative and alternate respectively to RRPC. 2nd by Paul, passed unanimously.
8. Ryan Decelle sent a quote of \$2500 for doing the Town Report. Ron made a motion to accept her offer. 2nd by Paul, passed unanimously.
9. Paul made a motion to change the December 25th meeting to December 18th. 2nd by Ron, passed unanimously.
10. The Wells Fire Dept asked permission to use the Wells Town Office to set up for a basket party. Ron made a motion to allow them to use the town office from November 28th though December 9th. 2nd by Paul, passed unanimously.
11. VLCT has a town fair scheduled in South Burlington October 3 and 4th.
12. Rutland County Solid Waste District sent information about their work and meetings.
13. Truck bids have been advertised.

14. Ron made a motion to adjourn at 7:52 PM. 2nd by Paul. Passed unanimously
