**Annual School District Meeting**  
**March 3, 2014 and March 4, 2014**

The legal voters of the Wells Town School District are hereby notified and warned to meet at the Multi-purpose room of the Wells Village School Building in said Town on Monday, March 3, 2014 at seven o'clock in the evening to transact the following business from the floor:

**March 3, 2014**

- Article 1. To hear the reports of the School Board and other District officials and act thereon.
- Article 2. To hold a public informational meeting (March 3, 2014) to discuss articles to be voted on by Australian ballot on March 4, 2014.
- Article 3. To transact any other lawful business to come before the meeting.

**March 4, 2014**

The legal voters of the Wells Town School District are hereby further warned to meet at the Wells Town Office on Tuesday, March 4, 2014 at ten o'clock in the morning at which time the polls will open and remain open until seven o'clock in the evening to vote on the following articles by Australian ballot:

- Article 4 To elect a moderator for a term of one (1) year.
- Article 5. To elect a school district clerk for a term of one (1) year.
- Article 6. To elect one (1) school director for a term of three (3) years.
- Article 7. Shall the voters of the Wells Town School District appropriate \$2,257,921.77 for the support of its school for the fiscal year beginning July 1, 2014 and ending June 30, 2015?
- Article 8. Shall the voters of the Wells Town School District authorize a transfer in the amount of \$20,000.00 from the surplus to the Maintenance Reserve fund which may be expended by the board of school directors to perform building maintenance?
- Article 9. Shall the voters of the Wells Town School District authorize a transfer in the amount of \$20,000.00 from the surplus to the Building Renovation Reserve fund which may be expended by the board of school directors to perform building renovation?



**March 3 and March 4, 2014**


The legal voters of the Town of Wells are hereby notified and warned to meet at the **MULTI-PURPOSE ROOM OF THE WELLS VILLAGE SCHOOL** in said town on **Monday, March 3, 2014** at seven o'clock in the evening and at the **WELLS TOWN OFFICE MEETING ROOM** on **Tuesday, March 4, 2014** at ten o'clock in the morning; on those days to consider and set upon the following propositions:

- \*1. To elect Town Officers as required by law for the ensuing year.
2. To receive reports of the Town Officers for the past year.
- \*3. Shall the Town vote a sum not to exceed \$ 838,836.00 to be used to defray the general expenses of the town and for maintaining highways?
- \*4. Shall the Town vote to appropriate \$12,000 to the Wells Volunteer Fire Department, Inc. to help defray operating and insurance expenses?
- \*5. Shall the Town vote to appropriate \$15,000 to the Wells Volunteer Fire Department, Inc. for the continuing payment on the KME pumper truck?
- \*6. Shall the Town vote to appropriate \$8,000 to the Granville Rescue Squad for their services to the Town of Wells?
- \*7. Shall the Town vote to appropriate \$12,000 to the Lake St Catherine Association ?
- \*8. Shall the Town vote to appropriate \$10,000 to the Lake St Catherine Conservation Fund, Inc.?
- \*9. Shall the Town of Wells authorize the Wells Select Board to employ a Town Manager? *(By Petition)*
- \*10. Shall the Town vote to elect two (2) additional Selectmen, each with a two (2) year term; and so that the terms are staggered, the year when the additional selectmen are first elected, the term of one selectman shall be for one (1) year and the term of the other selectman shall be for two (2) years and every year thereafter two (2) year terms? *(By Petition)*

**\* Means that these will be on Australian Ballot, March 4, 2014.  
The business part of the meeting will be held on March 3, 2014 at 7:00 PM. Polls for  
Australian Ballot will be open March 4, 2014 at 10:00 AM and will close at 7:00 PM.**
