WELLS LAKESIDE PARK & PAVILION RULES OF USE

- -THE PARK GROUNDS WILL REMAIN OPEN TO THE PUBLIC, BUT NO ACCESS TO THE PAVILION WHEN THE PAVILION HAS BEEN RESERVED FOR A PRIVATE FUNCTION.
- -CARRY IN CARRY OUT.
- -DOGS MUST BE LEASHED.
- -CLEAN UP AFTER YOUR ANIMALS.
- -NO OVERNIGHT PARKING.
- -NO CAMPING.
- -NO MOTORIZED BOAT LAUNCHING.
- -NO GLASS.
- -ALCOHOL IS PROHIBITED.
- -PAVILION MAXIMUM CAPACITY IS 80.
- -PAVILION USE IS FOR WELLS RESIDENTS AND NON-RESIDENTS.
- -APPLICANTS MUST BE AT LEAST 18 YEARS OF AGE.
- -AN ON-SITE LIAISON PERSON MUST BE IDENTIFIED AND MUST BE PRESENT AND AVAILABLE VIA CELL PHONE AT ALL TIMES DURING SET-UP, TEARDOWN AND DURING EVENT. THIS PERSON MUST HAVE THE AUTHORITY TO MAKE DECISIONS ON BEHALF OF THE EVENT ORGANIZER AND MUST BE ASSESSIBLE TO TOWN STAFF AND POLICE.
- -APPLICATIONS MAY BE SUBMITTED UP TO 6 MONTHS IN ADVANCE, BUT NO LESS THAN 30 CALENDAR DAYS IN ADVANCE.
- -A REFUNDABLE DEPOSIT MUST BE MADE AT TIME OF APPLICATION IN THE AMOUNT OF \$250.00 FOR CLEAN-UP OR DAMAGE. A CERTIFICATE OF INSURANCE IS DUE 14 DAYS PRIOR TO EVENT.
- -APPLICATIONS WILL BE APPROVED BY THE SELECT BOARD.
- -EVENTS ARE ALLOWED FROM 7 A.M. TILL DUSK.
- -NO FASTNERS OF ANY KIND ARE ALLOWED ATTACHED TO THE PAVILION.

- -VECHICLES ARE NOT ALLOWED ON GRASS AREAS. PARKING LOT ONLY.
- -ANY TENT SIZE OR STRUCTURE MUST BE APPROVED BY THE SELECT BOARD.
- -MAXIMUM SOUND DECIBEL IS 70.
- -BBQ'S, PORTABLE GRILLS OR HEAT GENERATING EQUIPMENT MAY NOT BE USED IN THE PAVILION.
- -FIREWORKS ARE NOT ALLOWED.
- -RULES ARE SUBJECT TO CHANGE AT THE SELECT BOARDS DISCRETION AND MAY BE MADE AT ANY TIME.
