Updates/Proof Reading of Draft 2025 Wells Town Plan.

Heather stated she has sent the Draft 2025 Wells Town Plan to the towns of Poultney Natural Resource Conservation District including Poultney, Pawlet, Middletown Springs and Tinmouth, VT. Heather has heard from Poultney and Pawlet. There has been no response from Middletown Springs or Tinmouth. Heather also stated Public Notice for 2025 Wells Town Plan was put in the Granville Sentinal which is out of Granville, NY. Granville Sentinal will also put the Public Notice in the Lakes Region Free Press which is now digital. Granville Sentinal will send a bill to Wells Planning Commission. Sharon asked Heather if she had time to work with her on multiple corrections that need to be made that she found when proof reading the Town Plan. Heather stated that she did not have any available time and asked for the corrections to be emailed. Sharon stated there were too many to put into an email and would be easier to meet. Heather stated that Sharon had an older version that she had proof read and that some of the corrections had already been made. Sharon disagreed and asked for confirmation of Sections 5.3 and 5.5 being in her version as she did not have it in the one she had. Heather stated that she had added those sections into the plan. There was additional discussion regarding errors

but due to disagreements the Commission agreed that they have done enough on the 2025 Wells Town Plan.

Next meeting is a Special Meeting for the Public Hearing on the Draft 2025 Wells Town Plan and is scheduled for Wednesday, March 19<sup>th</sup> at 7:00pm at the Wells Town Hall.
